ABSTRACT

Not more than 250 words in Font Size 10 Times New Roman should be presented in the first page along with title of the article and keywords in the following order:

Background: 1-2 sentences of background information followed by the objective of the investigation.

Methods: The method adopted in the investigation. This should be very clear and precise.

Results: The main findings of the investigation (no discussion or citation).

Conclusion: 1-2 sentences final conclusive statements on the work confirming whether or not the objectives were achieved.

Key words— Keywords should closely reflect the topic and should optimally characterize the paper. Use five key words or phrases in alphabetical order, separated by commas

1. INTRODUCTION

This should contain the background of the subject, statement of the problem, and relevant literature on the subject.

2. MATERIALS AND METHODS

2.1 Materials

2.1.1 Equipment

The presentation of specific details about instruments used, sources of specialized chemicals, and related experimental details should be incorporated into the text of the Material and Methods as a paragraph headed Materials. The general order for inclusion should be as follows: melting points; optical rotations; UV spectra; ECD and/or VCD spectra; IR spectra; NMR spectra; mass spectra; and chromatographic and other techniques.

2.1.2 Biological Materials

In a separate paragraph, experimental biological material should be reported as authenticated if cultivated or from a natural habitat, and the herbarium deposit site and voucher number should be recorded.

2.2 Methods

This section should contain enough details of new experiments and procedures to make them reproducible. Previously published procedures or methods in general use should only be cited. Important modifications of published procedures should be mentioned briefly.

2.3 Statistical Analysis

State the type of statistical analysis and tools used

3. RESULTS

Important findings should be presented with clarity and precision. Where necessary, results should be illustrated with figures or tables, but this should be kept to a minimum.



4. DISCUSSION

The discussion should not be a repetition of the results but should present an interpretation of the findings against the background of results obtained in previous studies on the subject.
